Owner use definition

Owner can sail up to 6 weeks per calendar year on his Yacht including exchange weeks from the 36 Dream Yacht Bases on sister ship or similar size model or smaller

2 WEEKS IN HIGH SEASON

+

2 WEEKS IN LOW SEASON

OR

6 WEEKS IN LOW SEASON

(One (1) high season week = Two (2) low season weeks)

An Owner package will be charged including (fresh water, gas, ice, cleaning of the boat, laundry) + security insurance or deposit. Owner has to refill the Full Tanks. The Owner package is applicable whatever the duration of the stay (1, 2 or 3 weeks, etc...).
